**CERTIFICATION OF COUNSEL IN
SUPPORT OF ORDER APPOINTING
SPECIAL AGENT FOR SERVICE OF
PROCESS**

I, CURTIS J. ROMANOWSKI, ESQ., do hereby certify that:

1. I am the attorney for the Plaintiff in the above entitled civil action.
2. I am executing this Certification in support of Plaintiff's application that the Court specially appoint (**e.g., Vahsh Guipadhi, Esq.**) for the purpose of serving the Defendant, who presently resides in (**Timbuktu**), with the Summons and Complaint.
3. I have been informed by Plaintiff that the usual place of abode of the Defendant is Nya Nya #44, Ho Ho Ho, Timbuktu. The Defendant cannot be served within the State of New Jersey, and therefore must be served pursuant to Rule 4:4-5(a), which states:

"Whenever, in actions affecting specific property, or any interest therein, or any res within the jurisdiction of the court, or in matrimonial actions over which the court has jurisdiction, wherein it shall appear by affidavit of the plaintiff's attorney or other person having knowledge of the facts, that a defendant cannot, after diligent inquiry, be served within the State, service may, consistent with due process of law, be made by any of the following 4 methods: (a) personal service outside this State as prescribed by R. 4:4-4(b)(1)(A) and (B)."

4. R. 4:4-4(b)(1)(A) and (B) state:

"(b) Obtaining In Personam Jurisdiction by Substituted or Constructive Service.

(1) *By Mail or Personal Service Outside the State.* If it appears by affidavit satisfying the requirements of R. 4:4-5(c)(2) that despite diligent effort and inquiry personal service cannot be made in accordance with paragraph (a) of this rule, then, consistent with due process of law, in personam jurisdiction may be obtained over any defendant as follows:

(A) personal service in a state of the United States or the District of Columbia, in the same manner as if service were made within this State or by a public official having authority to serve civil process in the jurisdiction in which the service is made or by a person qualified to practice law in this State or in the jurisdiction in which service is made; or

(B) personal service outside the territorial jurisdiction of the United States, in accordance with any governing international treaty or convention to the extent required thereby, and if none, in the same manner as if service were made within the United States, except that service shall be made by a person specially appointed by the court for that purpose."

3. In order to effectuate service upon the Defendant in accordance with the aforementioned *Rules*, on **(Date)**, I telephoned **(e.g., Vahsh Guipadhi, Esq.)**, an attorney admitted to the Bars of **(Timbuktu)** and who is presently practicing law there. Mr. **(e.g., Vahsh Guipadhi, Esq.)**, who is not personally known to either me or the Plaintiff, was selected from a list of attorneys appearing in an internet search using the key words "Timbuktu attorney," who practices near the Defendant's residence. A copy of **(e.g., Vahsh Guipadhi, Esq.)**'s home page is attached hereto as EXHIBIT A. On **(Date)**, **(e.g., Vahsh Guipadhi, Esq.)** agreed to personally deliver the Summons and Complaint to the Defendant at his place of residence, which happens to be only a short distance from his law office.

4. I therefore, respectfully requests that **(e.g., Vahsh Guipadhi, Esq.)** be specially appointed by this Court for the purpose of serving process upon the Defendant.

5. I certify that the foregoing statements made by me are true. I am aware that if any of the foregoing statements made by me are willfully false, I am subject to punishment.
